MARKET REVIEW

- Throughout October 10-year government bond yield declined by 28bps to 7.008%. IHSG rose 0.96% MoM, closed at 6,228.3. Sectors driving index performance include JAKBIND (+7.63%) and JAKPROP (+5.38% MoM).
- President Jokowi inauguration was held on 20th October 2019, followed by "Kabinet Indonesia Maju" announced in the same week. We view the new cabinet positively in which government-supporting parties make up 74% of the total available position.
- Inflation in October'19 was below consensus expectation, recorded at 3.13% YoY (0.02% MoM). Meanwhile, IDR appreciated 1.07% MoM against USD, closed at 14,043 on 31th October 2019.
